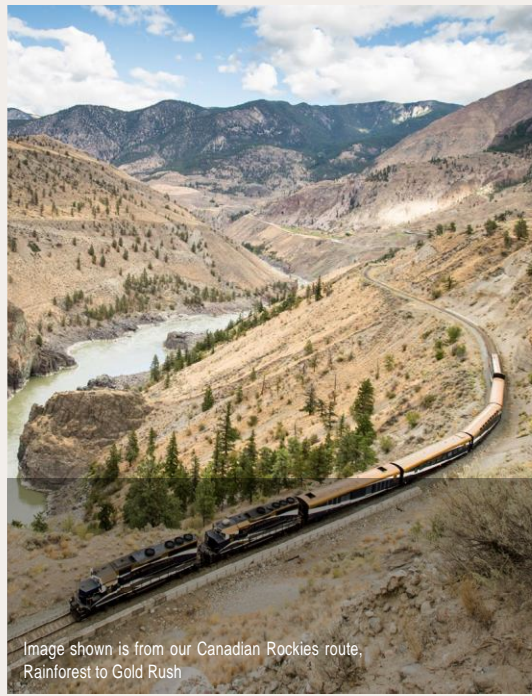

Antelope Canyon

DAY 1 DENVER

Transfer from the airport to your hotel. After checking in, explore Denver on your own. The LoDo district, with wonderful shops and restaurants, is within walking distance of your hotel. Overnight at Maven Hotel, Denver or similar.

DAY 2 DENVER TO GLENWOOD SPRINGS

(B) (L)

Board the Rocky Mountaineer in Denver to start your rail journey. Cross the Continental Divide as you take in the spectacular views of rugged canyons and Colorado River before arriving at the resort town of Glenwood Springs. Breakfast and lunch included onboard. Overnight in Glenwood Springs. Hotel to be confirmed 30 days prior to stay.

DAY 3 GLENWOOD SPRINGS TO MOAB

(B) (L)

Depart Glenwood Springs and travel onboard Rocky Mountaineer. Cross the Colorado-Utah border with stunning mountain views in the background. Red sandstone landscapes emerge as you approach Moab. Meet your tour guide for a scenic drive to **Dead Horse Point State Park** for a picnic lunch and tour of **Canyonlands National Park** in the afternoon. Breakfast included onboard and picnic lunch in the park. Overnight at HooDoo Moab, Curio Collection by Hilton or similar.

DAY 4 MOAB

(B) (D)

Tour the highlights of **Arches National Park**. The unique geology of the area created the highest concentration of natural arches in the world with over 2,000 named arches within the park boundary. After the tour, enjoy free time to explore Moab and have lunch on your own. In the afternoon, join the group for a Jet Boat Ride on the mighty Colorado River through spectacular red rock canyons and learn about the river's ecosystem, geology and history. Enjoy dinner with a million-dollar view at the Sunset Grill. Overnight at HooDoo Moab, Curio Collection by Hilton or similar.

DAY 5 MOAB TO PAGE VIA MONUMENT VALLEY

(B) (L) (D)

Depart Moab and travel to Monument Valley, a sacred place to the Navajo. Your Navajo guide will take you for a scenic tour of the area to see the sights, experience the culture and traditions. An optional hike to Horseshoe Bend in Lake Powell National Recreation Area is available this afternoon. Overnight at Lake Powell Resort, Page or similar.

DAY 6 PAGE

(B)

This morning tour through Antelope Canyon to admire its mysterious and haunting beauty. In the afternoon, enjoy a scenic cruise on Lake Powell and see the contrast of the red rock walls and emerald blue waters. A visit to Glen Canyon Dam Visitors Center included. Evening at leisure. Overnight at Lake Powell Resort, Page or similar.

DAY 7 PAGE TO BRYCE CANYON VIA GRAND CANYON

(B) (D)

Enjoy a scenic drive and travel through Marble Canyon and pass Vermillion Cliffs before climbing the Kaibab Plateau and entering the **Grand Canyon National Park North Rim**, a UNESCO World Heritage site. Have lunch on your own at Grand Canyon Lodge and have a walk out to Bright Angel Point. In the afternoon, visit **Bryce Canyon National Park** for sightseeing. The vibrant colours and unearthly shapes of Bryce Canyon spark the imagination. Later tonight, join the group for a private Stargazing Experience with local astronomers to explore the wonders of the night sky and our universe. Overnight at Best Western Bryce Canyon Grand Hotel or similar.

DAY 8 BRYCE CANYON TO LAS VEGAS VIA ZION

(B)

Return to **Bryce Canyon National Park** for a morning view before visiting Utah's oldest and most famous **Zion National Park** to admire massive 2,000-foot high formations and towers, the Mount Carmel Tunnel, Zion Canyon and the Virgin River. Check in at your Las Vegas hotel later this afternoon and enjoy the rest of the day on your own. Overnight at Caesars Palace Casino Resort, Las Vegas or similar.

DAY 9 LAS VEGAS

Transfer to the Las Vegas Airport for your departure home.

You agree to review your itinerary & other travel documents for accuracy and to inform us promptly of any issues. You agree to provide Accent on Travel required information including your name as it appears on your government issued ID to process travel documents accurately. You assume full and complete responsibility for checking and verifying any and all passport, visa, vaccination, or other entry requirements of your destination and your connecting points, and all conditions regarding health, safety, security, political stability, and labor or civil unrest at such destination. Passports must be valid for 6 months or more after the date of entry for international travel. I further acknowledge that beginning October 1, 2021, I must present a driver's license or another form of ID that complies with the Federal Real ID Act (www.dhs.gov/real-id).

Accent on Travel acts as a sales agent for any airline, hotel, tour company, cruise line or other service provider named in your itinerary or confirmation ("Suppliers"). We are not responsible for the acts or omissions of the suppliers or their failure to adhere to their own schedules, provide services or refunds, financial default, failure to honor future trip credits. We have no special knowledge regarding the financial condition of the Suppliers and no liability for recommending a trip credit in lieu of a refund. We strongly recommend the use of a credit card to exercise your rights under the Fair Credit Billing Act. However, if we are the credit card merchant, our role is to facilitate the sale and to provide design and consulting services, collect funds on your behalf, and remit funds to the Suppliers. In the case of a full group cancellation due to circumstances beyond our control, the group travel program will be moved to another departure date and you will be notified. Payments made will become future travel credits applied to the new booking if you choose to proceed and a service fee for our efforts will apply. If you choose to cancel off the new departure date, any applicable cancellation policies in place will apply. Accent on Travel planning, change, and other fees at Accent on Travel and understand these fees are nonrefundable regardless of travel taking place. If a Supplier drops the price of a trip after booking, we will assist with the rebooking if the offer applies and a fee may apply. We do not guarantee any refunds or successful rebookings.

Travel arrangements involving airline and cruise components are subject to Suppliers' supplemental price increases that may be imposed by the supplier and/or government, even after you have completed your purchase. You hereby consent to any such price increases and authorize your credit or debit card to be used for them.
